1	Site Plan		
	to a minimum scale of 1:200 or 1:500 must be provided showing all proposed and existing structures as well as all relevant setbacks, north point, driveway, site datum, spot levels, contours levels and finished floor levels along with any proposed retaining walls and all street features, i.e. light poles, cross over, street trees etc.

	to a minimum scale of 1:100 must be provided showing layout, room functions, windows and door locations, clear dimensions, electrical fixtures such as hard-wired smoke detectors, .		
3	External Elevations		
	to a minimum scale of 1:100 must be provided showing materials, sizes of windows and door openings (including cyclone screens if applicable), ground, floor and roof levels.		
4	Section View/s		
	to a minimum scale of 1:20 showing construction details such as materials and insulation requirements, floor to ceiling heights, roof frame and floor frames and all dimensions.		
5	Structural certification		
	Engineers certification that the building is structurally sound which should include the following:		
	Any structural elements such as walls, columns, roof beams, suspended floors or retaining walls supporting building loads or higher than 0.5m. The report should include a check on:		
	Wind loadings, Earthquake prone areas, soil conditions.

6	Certificate of Site Classification		
	Only required for new buildings or extensive ground floor additions		
7	Bushfire Attack Level (BAL)		
	A BAL report is required if located in a bushfire prone area. The construction of the building is required to comply with AS 3959 Construction in bushfire prone areas. (see Landgate bushfire map to determine if the property is in a bushfire area)		
8	Copies of BA20 Consent or Court Order for building work		
	If the building work adversely affects other land or encroaches onto other land.		
9	Energy Efficiency Buildings require an energy efficiency report to demonstrate compliance with BCA Part 3.12.		
	Note: additions and renovations can be subject to certain concessions as determined in the State Building Regulations.		
10	Termite Barrier		
	A copy of the nominated termite barrier details are to be provided as per BCA Vol 2 Part 3.1.3 (if applicable) or a certificate from a fully qualified pest controller.		
11.	Electrical and plumbing		
	Compliance certificates required for any electrical or plumbing installations.
